DIRECTIONS DATED 22 MAY 2006

The Chief Justice has given the following directions concerning the above matter.

1. The application for leave to appeal against the judgment of the Supreme Court of Appeal is set down for hearing at 10:00 am on Thursday 17 August 2006.
2. The record shall consist of the full record in the proceedings before the High Court and the Supreme Court of Appeal, and all documents lodged in the present application. The applicant must lodge the record, properly paginated and indexed, with the Registrar of this Court by Thursday 15 June 2006.
3. Written argument, which shall include argument on the merits of the appeal, shall be lodged as follows:
 - (a) by the applicant not later than Thursday 22 June 2006, and
 - (b) a reply by the respondent not later than Tuesday 4 July 2006.
4. The Chief Justice has noted that the incident giving rise to this litigation occurred in October 1995, yet judgment was only handed down by the Cape High Court on 6 April 2005. The applicant is required to lodge an affidavit on or before 22 June 2006 setting out the history of the matter to illustrate why it took such a long time for this case to be heard by the High Court. The respondent is required to lodge an affidavit responding to the applicant's affidavit on this issue on or before 4 July 2006. Thereafter further directions may be issued on this aspect of the case.
