4. The record in the proceedings must consist of the record before the High Court together with the judgment of the High Court as well as all the papers filed in the proceedings before this Court.
5. Written argument by the applicant must be filed not later than **Wednesday 27 August 2008** and by any of the respondents not later than **Wednesday 3 September 2008**.
6. Any party which seeks to intervene as amicus curiae may do so in accordance with the Rules of this Court.
