

**FOUNDING AFFIDAVIT: APPLICATION FOR CONDONATION**

---

I, the undersigned,

**RASHAAD YUSUF DADOO**

do hereby make oath and state as follows:

1. I am an adult male attorney of the High Court of South Africa. I practice as such under the name of the Legal Resources Centre (LRC) with its principal place of business at Second Floor, West Wing, Women's Jail, Constitution Hill, 1 Kotze Street, Braamfontein.
2. The LRC are the attorneys of record for the Second Applicant (amaBhungane) in CCT103/25 and CCT144/25. As such, I am duly authorised to depose to this affidavit.
3. The facts contained in this affidavit are to the best of my knowledge and belief both true and correct, and, except where the context indicates otherwise, are within my personal knowledge.
4. The structure of this affidavit is as follows:

#### **PURPOSE OF THIS APPLICATION**

5. The purpose of this application is to seek condonation of the late filing of amaBhungane's replying affidavit.
6. On 2 October 2025, this Court issued directions in case numbers CCT103/25 and CCT144/25. At paragraph 4 of the directions, this Court directed that the respondents must file their answering affidavits by Thursday, 13 November 2025.
7. It was further directed that amaBhungane must file any replying affidavits by Thursday, 27 November 2025. A copy of the directions is annexed hereto marked "RD1".
8. The replying affidavit was filed electronically and physically on 4 December 2025. Thus, it is five (5) court days late.

#### **EXPLANATION FOR THE DELAY**

9. The directions referred to above and annexed as "RD1" called upon the Respondents to file their consolidated answering affidavit by 13 November 2025.

10. On 18 November 2025, our office communicated with the Respondents that the date of 13 November 2024 for filing of their answering affidavits had lapsed, and requested clarity on whether they intend to file any answering affidavits. This email is annexed as “**RD2**”.
11. In response to annexure RD2, the state attorney stated that the Speaker of the National Assembly (“the Speaker”) intends delivering an answering affidavit and that condonation for the late filing will be sought. This email is annexed as “**RD3**”.
12. We only received the answering affidavit in response to our client’s consolidated founding affidavit on 19 November 2025, five (5) court days after the due date set out in the 2 October 2025 Directions. A copy of the service email is annexed hereto marked “**RD4**”.
13. Immediately after receiving the answering affidavit, the LRC had to consider the answering affidavit, consult with amaBhungane and their counsel, and then prepare the replying affidavit. A first draft of the replying affidavit was delivered to our client for review on 28 November 2025.
14. After receiving comments from our client, we settled the comments and edits from amaBhungane and delivered a second draft of the replying affidavit to counsel on Sunday, 30 November 2025. The LRC was only able to finalise the replying affidavit for service on 3 December 2025 due to the significant amount of edits that needed to be made.
15. While we endeavoured to ensure that the replying affidavit was filed on 27 November 2025, given the late receipt of the answering affidavit of the Speaker, the complexity and depth of the issues which needed to be addressed in the reply,

and the numerous steps we needed to take to ensure it would assist the Court, we unfortunately could not meet that short timeframe.

### **DEGREE OF LATENESS**

16. I accept that any lateness, regardless of the length of the delay, is a serious matter.

However, I submit that the delay is not inordinate. The replying affidavit is delayed by only five (5) court days. In light of our explanation for the delay, I humbly submit that the delay is justifiable.

### **PREJUDICE**

17. I submit that, given that the delay is minimal, there can be no prejudice to the Respondents. Furthermore, a hearing date has not been allocated for this matter. Since, as the matter currently stands, no further affidavits are pending from either of the parties, and since all parties are required to wait for an undefined period of time before set down directions are issued, there is sufficient time for the Respondent's to consider amaBhungane's replying affidavit despite the delay. Therefore, the Respondents will not be prejudiced by the delay.

### **CONCLUSION**

18. I respectfully submit that it is in the interest of justice for the late filing of the Second Applicant's replying affidavit to be condoned. I further submit that I have shown good cause for the period within which the late filing of the replying affidavit should be condoned.

19. I respectfully request that this Court grant the order as set out in the Notice of Motion.

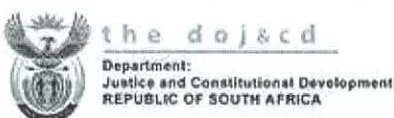

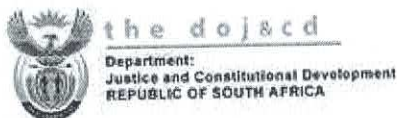
