**DIRECTIONS DATED 31 OCTOBER 2013**

The Chief Justice has issued the following directions:

1. The appeal is set down for hearing on Wednesday 12 February 2014 at 10h00.
2. The opposing parties must file an agreed statement of facts based on the factual findings of the High Court that are pertinent to the issues, on or before 20 November 2013. If no agreement can be reached:
  - (a) The appellants must, on or before 27 November 2013, file a statement setting out the factual findings made by the High Court that they dispute, together with only those portions of the record that are relevant to the impugned findings.

- (b) The respondents must, on or before 4 December 2013 and if they so wish, file a statement setting out the factual findings made by the High Court that they dispute, together with only those portions of the record that are relevant to the impugned findings.
3. On or before 11 December 2013 the appellants must file a paginated record that comprises the statement of facts agreed upon, or the parties' respective statements of facts and the necessary portions of the record, as well as a copy of the judgment or order in the High Court and Supreme Court of Appeal.
4. Written argument on the merits of the appeal must be lodged by—
  - (a) the appellants, on or before 20 December 2013; and
  - (b) the respondents, on or before 3 January 2014.
5. Further directions may be issued.
