

- 1.1. Upholding the cross-appeal, by ordering the Applicant to pay the Second Respondent's costs in the High Court Application, including the costs of two Counsel.
 - 1.2. Ordering the Applicant to pay the Second Respondent's costs in the Cross-appeal, including the costs of two Counsel.
2. Leave to cross-appeal against the finding made under the above-mentioned case number by the Western Cape High Court per Davis J on 22 November 2012, in terms of he found the following;
- 2.1. A motion of no confidence in terms of section 102 of the Constitution of the Republic of South Africa, 1996 "is inherently urgent" and should be treated as a matter of urgency;
 - 2.2. The Rules of the National Assembly do not provide for a determination of what constitutes 'urgency'.
3. Further and/ or alternative relief.
